La Paz 4-H Requirements To Complete The 4-H year

Adopted 9/9/02 by La Paz 4-H Council and the 4-H Office

Requirements to complete the 4-H year

All 4-H members are required to meet the following standards each year. Your club may have additional requirements and will notify the youth members by the 1st 4-H meeting of the year.

- Adhere to the expectations of the responsibility form attached to the youth enrollment sheet.
- Attend at least 70 percent of regular club meetings and/or activities.
- Complete a 4-H project, doing one's own work with minimal assistance from parents or others.
- Give a club or county 4-H public presentation.
- Complete a project record book and turn it in to your Community Club Leader by their specified due date.
- Participate in 4 recognized county events throughout the year.

The community club leader of each youth's respective club determines End-of-Year 4-H status. End-Of Year packets are due to the 4-H office on the **first Friday of August** each year. Final End-of Year 4-H status for each youth must be clarified by the **last Friday of August**.
