Afghanistan-Pakistan Activities Quarterly Report-VI (January-February-March 2004) Sustainable Development of Drylands Project IALC-UIUC

Introduction:

There were two principal activities completed this quarter:

The first two courses on the calendar year 2004 list of offerings were conducted concurrently at the Northwest Frontier Province Agricultural University (NWFP-AU) during the period February 10 through March 9. The titles and numbers of those courses were: "Orchard and Nursery Management" (0104) and "Sustainable Use of Water Resources" (0204). Both courses were filled to capacity.

Work was completed on an AID/Kabul buy-in, which will provide \$400,000 in supplemental funding to support a varied menu of training programs that are scheduled for the balance of fiscal year 2004. Based on the recommendation of AID/Kabul, we used the Job Order and Proposal format to access funds that have been allocated to the RAMP Project. Chemonics International Inc. is the implementing contractor for RAMP (Rebuilding Agricultural Markets in Afghanistan Program).

Details on these principal activities are given in the section which follows:

Activities of this period (January 1-March 31):

The two courses completed this quarter bring us to a total of five organized short courses that have been conducted during the life of our Cooperative Agreement. A total of 84 Afghan trainers and advisors have been reached through these courses. It is our intent to reach another 100 Afghan agriculturalists through these short courses during the remaining months of 2004. Our plans for specialized short term individual training programs and M.S. degree starts will add to the total number of Afghans reached.

Documents annexed to this report will provide more detail on the two courses completed this quarter. The documents attached are:

- 1. The daily schedule of topics covered, training activities used, and instructors responsible; covering the four-week duration of each course.
- 2. Lists of participants in each course, with their background information. We were especially pleased that four female participants were part of the Ministry of Irrigation contingent that was sent to the Water Resources course.
- 3. Summaries of the evaluations completed by the participants in both courses.

M. Sharif Abbasi, Training and Conference Coordinator for RAMP, was able to observe during the last week of instruction and participate in course closing ceremonies.

A detailed proposal and the job order were submitted to the RAMP Project office in Kabul on January 23. A portion of Dr. Qayyum's January TDY in Illinois was used to prepare this submission. These supplemental funds have been programmed to support human capacity development through the following: 1) Five more organized short courses offered during the balance of 2004; 2) Specialized individual training of two weeks duration for up to 16 scientists or administrators; 3) Ten M.Sc. degree program starts; 4) One Assistant Training Coordinator, to serve as the IALC/Illinois point-of-contact and project representative in Kabul. We were informed that our job order was submitted to AID/Kabul on February 17, approved at that level before the end of February, and returned to RAMP for their further action and processing.

In spite of everyones' best efforts, good intentions, and belief in the value of these training programs; the approval and processing of our job order was delayed. Near the end of this reporting period, a recommendation was made that our Assistant Training Coordinator be located in the office of Mercy Corps-Afghanistan instead of with RAMP, as had been the previous plan. The Illinois Team has accepted this recommendation, thus all the key players (AID, RAMP, Mercy Corps, and UIUC) have reached agreement that our use of the Mercy Corps location is in everyone's best interest. With this decision made, the last hurdle was cleared. On March 31, we were informed that the RAMP office in Kabul had approved our job order and begun processing the transfer of funds.

The two courses completed in February/March (0104 and 0204) were supported by core funds in the cooperative agreement. The next two courses on the 2004 calendar (that calendar was attached to the previous quarterly report) are dependent on the AID/Kabul buy-in through RAMP for financial support. Those courses were scheduled to begin on March 22. They were to be held in Kabul, using classrooms and facilities at Kabul University, with professors from the NWFP-AU as instructors. The titles of the courses to be offered in Kabul are: "Enterprise Development and Management Skills" (0304) and "Extension Methodology and Technology Transfer" (0404). The March 22 start date of these courses had to be postponed when the approval and processing of our job order for supplemental funding was delayed. Now that funds have been released, a May 1 start date has been set and course announcements are being distributed by the Kabul–based Assistant Training Coordinator. Those course announcements are attached to this report.

We realize that we must move toward offering more courses in Kabul and/or at other locations in Afghanistan. Using training sites in Afghanistan will introduce an element of uncertainty, with new and unique challenges. To begin addressing these challenges, Dr. Qayyum used some of his January TDY to obtain resource materials from selected UIUC/SIUC units and staff, for use by NWFP-AU faculty who are delivering the above-mentioned courses in Kabul. Course outlines and syllabi were reviewed by Illinois faculty and comments were carried back. We were especially fortunate that the UIUC Office of Information Technology and Communication Services donated instructional materials valued at more than \$600 for use in these upcoming

courses. A review and critique was also done by UIUC faculty on the plans and syllabus for "Integrated Pest Management" (0604) which will be offered in Peshawar June 10 to July 9.

Another use of Dr. Qayyum's TDY was in preparation of hand-out materials and a PowerPoint presentation that would eventually be used in the February 12 briefing for staff of the USAID/Washington Bureau for Asia and the Near East. A preliminary version of that presentation was used at the first meeting of the Afghanistan-Pakistan Training (APT) Group, which was held on January 13. It was especially valuable to have Dr. Qayyum with us as a participant in the APT Group organizational meeting. This PowerPoint presentation was later given by Prof. Jeff Dawson on March 3 in his capacity as UIUC representative to the IALC Technical Advisory Committee.

Responses to our short courses offerings, especially from NGO's, continue to be positive and gratifying. As they nominate their employees to participate in these courses, we receive comments such as the following from COOPI – Cooperazione Internazionale:

"The course is very well planned and perfectly answers specific training options that we are looking for. At the moment they are completing an 8 month project aimed to develop vegetable production in the peri-urban agriculture of Kabul. In the next months our organization counts to extend its activities also to orchard and nursery management."

and a similar endorsement from IRC – International Rescue Committee:

"Your courses have been a success among the staff. They all are very motivated. Please remember if there is any cancellation or extra place, I will be happy to send extra staff to the course. Also if there is any other course schedule for the future I would be happy to start looking into it".

Another example is the positive response from Mercy Corps to the proposal that they provide office space and support to the Assistant Training Coordinator who will represent the IALC/Illinois in Kabul. Mercy Corps has also requested a tailor-made two-week course, specifically for a group of 15 to 20 women, on fruit and vegetable preservation.

Activities planned for the following quarter (April 1 - June 30):

With the release of supplemental funds by RAMP, our Assistant Training Coordinator will be installed in the offices of Mercy Corps-Afghanistan to begin serving as the IALC/Illinois point of contact in Kabul. An exceptionally well-qualified individual has been identified and has reported for duty. Mohammad Agha Jabarkhil is an Afghan national, who holds B.Sc. and M.Sc. degrees from the NWFP-AU. He reads, writes and speaks English, as well as all the ethnic languages used in Afghanistan. His c.v. is available on request. Mr. Agha will be a critical part of our plans to deliver the next two courses in Kabul. He will distribute course announcements, screen and select nominees, then provide participants with advance information. His responsibilities will also include monitoring and providing logistical support while the courses are being conducted.

We have been informed that review of our "Proposal to Strengthen the NWFP Agricultural University" is nearly complete. AID/Islamabad is expected to deliver their comments and a preliminary response in April. The next steps on this potential set of activities, in terms of working out contracting mechanisms and implementation plans, could occupy much of our time and attention during this quarter. The additional financial support that we hope to secure through this proposal could prove extremely helpful to our long-range overall plans for the Afghanistan training program.

A revision and extension of the existing Memorandum of Understanding (MOU) between the NWFP-AU and the Illinois universities (UIUC and SIUC) will be on the agenda for the April meeting of the NWFP-AU Syndicate (Faculty Senate). Shortly after that, the MOU should be signed by the Vice Chancellor and on its way to Illinois for signatures on our respective campuses. We need this agreement to formalize our continuing cooperation. Subsequent to the MOU, an Implementation Letter will be drawn up between the Field Office and the Vice Chancellor's office, to clarify operational matters related to training program delivery. We will also continue our efforts to "broker" a working relationship and a formal agreement between the NWFP-AU and the Kabul University Faculty of Agriculture. The Illinois universities may be included as a cooperating third party in the envisioned agreement between these two universities.

Later in the quarter, preparations will need to be made for another APT Group meeting. This group will likely hold two meetings each year, in February and July, so they are timed to precede the regular meetings of the IALC Technical Advisory Committee. Formation of the APT Group was announced in the previous quarterly report, but details on group membership were not included. Membership has been drawn from two sources: A) TIPAN Project veterans and B) Active faculty from UIUC and SUIC.
